5. PLANNING:

15/00266/AS Griffin Farm, School Road, Appledore. New residential access and driveway. The application was supported.

15/00444/AS Rangers, Woodchurch Road, Appledore. Part Two storey extension and part single storey extension and erection of an open porch. The application was supported.

New ground floor sash window in flank elevation; new bathroom at second floor level; demolition and reconstruction of garden boundary wall to the rear east elevation; structural restraint of rear wall; removal of rotten section of timber beam and replacement with masonry; replacement of rotten beam over cellar staircase window; installation of wood burning stove and flexible metal flue liner to existing fireplace. 15/00231/AS Saxon House, 34 The Street, Appledore. Conversion of coach house to a holiday let and ancillary annex and refurbishment of existing lean-to greenhouse.

15/00232/AS Saxon House, 34 The Street, Appledore. Conversion of coach house to a holiday let and ancillary annex. Refurbishment of existing greenhouse, dismantle rear eastern end, excavate and underpin the foundations, reinstatement of door to north elevation, rebuild roof timbers, insert breathable membrane, re-tile using existing and matching tiles, insert conservation roof light to south, repair first doors to west and insert bi-fold doors inside doors. Insertion of French doors to south elevation. Build new floor slab to ground floor, internal wall and mezzanine structure to first floor.

6. **PUBLIC TOILETS:**

The door closure mechanism has been repaired.

7. HISTORICAL INFORMATION BOARD, outside the Church:

The renovation cost will be in the region of \pounds 750 +. It was proposed, by Cllr. A. D. Winter, seconded by Cllr. D. Hancock that in principle this should be renovated, subject to a definite quotation and full details and this was unanimously agreed.

8. ITEMS OF INTEREST:

Notification from K.C.C. Highways of closure of the School Road for up to two days as from 22nd April for remedial repairs. In view of the forthcoming Parish Council election when there is only one candidate standing, in an uncontested election, so is automatically elected as a councillor, it will now be necessary for Ashford Borough Council to call another election to fill the six vacancies, until then the Parish Council is inquorate. Should there be more

than six candidates any election expenses will be at the cost of the Parish.
